### II. WELCOME & INTRODUCTIONS

- Ana Maria Cetina welcomed everyone.
- Overviewed what topics the meeting will cover and introduced guest speaker-Tisha T. Banker

### III. IMMUNIZATIONS ACROSS THE LIFESPAN

- a. **Guest Speaker** – Tisha T. Banker, Co-founder of Vaccinate California
  - Vaccine hesitant mother of two children wanted to choose an alternative immunization schedule for her children.
  - Worked on abolishing PBE's and was a parent's voice of SB277.
  - Rallied with community members and sponsor partnerships to support the hard work in monitoring and fighting efforts to defeat SB277.
- b. **Meningococcal B Recommendations** – Alyson Cram, Registered Nurse Health Educator
  - Meningococcal B and ACWY factsheets were provided for reference.
  - Reviewed Meningococcal B vaccines Bexsero-2 dose series and Trumenba-3 dose series.
  - Vaccine products cannot be used interchangeably.
- c. **SB277**– Alyson Cram, Registered Nurse Health Educator
  - SB277/792 updated information sheet was provided for reference.
  - Reviewed Shots for School website screenshot for further clarifications.
  - Hepatitis B vaccine is not required if first entering California after

- kindergarten, but is recommended by ACIP.
  - Students with IEP's cannot be denied special education services; may be enrolled without meeting vaccination requirements.
  - Still ask students with IEP for immunization record and screen for requirements. Handwrite IEP on their school immunization record if parents opting not to get immunizations.
- d. **SB792** – Alyson Cram, Registered Nurse Health Educator
- Preschool/Child Care & Volunteers are required to adhere to SB792 as of September 1, 2016.
  - Vaccinations required:
    - i. Influenza, documentation of receipt required annually dated between August 1<sup>st</sup>- December 31<sup>st</sup>. (Employees may decline the influenza vaccine however, documentation is required annually.)
    - ii. Pertussis (whooping cough) vaccine became available in 2005. (Documentation of Tdap would be dated in 2005 or later.)
    - iii. Measles, proof of vaccine or immunity must be stated by physician or proof employee was born before 1957.

**IV. NATIONAL IMMUNIZATION AWARENESS MONTH (OVERVIEW PROMOTION/GROUP ACTIVITY)**

- a. **Week 1- Vaccines are not just for kids**
- Screen not only child immunizations but the parents as well during visits.
  - Promote NIAM through newsletter, website, posters, and education board.
- b. **Week 2- Protect yourself and your baby**
- Offer vaccine not only to pregnant mom but other contacts to baby.
  - Access to information table, posters available for patients to review.
  - Visit OBGYN offices to provide education and awareness.
  - Mailed information flyers to patients.
- c. **Week 3-A healthy start begins with on-time vaccination**
- Conducted chart audits.
  - Reminder recall through text messages to parents.
  - New parent support groups to discuss immunizations.
  - Schedule next visit in sync with immunization needs.
- d. **Week 4- Ensure a healthy future with vaccines**
- Back to school registration, and handouts available at front office & health office of schools.
  - Report card notifications for 6<sup>th</sup> graders.
  - Electronic notifications.
  - Video and radio announcements.

- V. CAIR Update** – Twila Crook, CAIR Implementation Specialist
- CAIR2 project timeline, August 1, 2016-April 30, 2017.
  - Reviewed CAIR2 new features.
  - CAIR2 user trainings begin September 1, 2016 for active users.

**VI. VFC Update** – Angela Rhoades, VFC Field Representative

- Flu – reminder Flumist is not provided by VFC program due to recent recommendations.
- Pentacel vaccine supply still delayed, however immunizations should not be delayed due to availability.
- Data loggers will be required in 2017 to monitor temperatures for storage units.
- Reviewed temperature logs and pointed out where to record temperature excursions.
- Reviewed steps/process for reporting temperature excursions.
